INVENTORY AND SCREENING NOTES:

HPD prepared using a Nested Materials Inventory with a product threshold at 1,000 ppm. Cendrex's doors include a multitude of steel based materials. It was chosen in this HPD to group all non-insulated steel access doors with the same function regardless of the steel used. Steel-based components are similar and the variation comes from alloying elements and/or surface treatment which both represent small quantities in the overall steel products. More details about how residuals and impurities were considered available in the appropriate sections. Reaction polymer materials are present in the product. Guidelines for reporting reaction products are still under development by HPDC. Les Industries Cendrex Inc company will update the HPD accordingly once these guidelines get published. In this HPD, for powder coat, substances at or above the threshold, have been declared as unreacted.
