PRODUCT DESCRIPTION: PLANFIX-FINE is a polymer-modified, cement-based, extra fine-grained putty mortar, for indoor or outdoor application. With the addition of water, a paste of very good workability is formed, ideal for thin-layer applications (e.g. puttying). Because of its particle-size, it can also be applied with a gunite machine. It is classified as a PCC R2 type mortar, for concrete repairs, according to EN 1504-3.
