PRODUCT DESCRIPTION: Pyrok's StarSilent® Superfine Acoustical Plaster System consists of acoustical panels manufactured from recycled crushed glass. StarSilent Plan is used to mud the screw heads, and a light coat is applied over the StarSilent Fix on the panel joints prior to application of the StarSilent Superfine Plaster. The Superfine finish appears smooth when applied at heights above 18 feet, and thus is especially recommended with high ceiling heights where critical light may highlight the hand troweling limitations of the smooth system. When this finish is desired, specify StarSilent "Superfine". The result is a smooth, seamless, sound absorbing, durable plaster system for walls and ceilings.

## Section 5: General Notes

Pyrok's StarSilent® Superfine Acoustical Plaster System is comprised of a sound absorbing board that allows jointless areas of up to 1800 square feet. StarSilent boards are installed in a staggered pattern and are joined together with StarSilent Fix adhesive. StarSilent Plan is used to mud the screw heads, and a light coat is applied over the StarSilent Fix on the panel joints. The StarSilent Superfine finish is then applied in 3-4 light coats. Each coat requires 12 hours for drying. Minimum temperatures should be maintained at 50 degrees Fahrenheit or higher. The Superfine finish is especially recommended when there are high ceiling heights, and where critical light may highlight the hand troweling limitations of the Smooth system.
