It is based on negatively charged molecules of synthetic polymers which when dispersed within the fresh concrete absorb onto the surface of the cement grains. After the molecules are absorbed they create an electrostatic repulsion amongst the cement grains, making their dispersion in water easier and consequently the concrete mix is more flowable.
