PRODUCT DESCRIPTION: The Atmosphere Collection by Trove for KnollTextiles is an exploration of how intrinsic forces in nature shape patterns. The Atmosphere Collection is printed on nonwoven Thermoplastic Olefin (TPO) favoring the look, feel and performance of a commercial vinyl with a reduced environmental impact. It features a linen emboss that is exclusive to KnollTextiles. TPO is durable against commercial cleaning products including bleach solutions. The collection is UV printed, one of the most sustainable printing processes available in the market, with water-based inks.
