PRODUCT DESCRIPTION: Inspired by archival fabrics Bourette (1973) and Accord (1984), Feeling Plaid is a fun and chic large-scale full repeat pattern. The dynamic mixture of colors in Feeling Plaid is achieved with a custom loom set up where 5 colors of wool and 5 colors of rayon are used in both the warp and weft directions. The split of rayon and wool create a beautiful balance of matte (wool) and luster (rayon) in the upholstery.
