Product Description: This HPD applies to all configurations of Ernest Maier Normal Weight Concrete Masonry Unit with CarbonCure™, all configurations conform to the following: ASTM C90 Load Bearing Concrete Masonry Units, CSI Specification Sector 04 22 00 - Concrete Unit Masonry, UNSPSC Code 30131502 - Concrete Blocks. The Normal Weight Concrete Masonry Unit is produced at Ernest Maier's plant in Bladenburg, Maryland using CarbonCure's technology. The CarbonCure™ process incorporates waste carbon dioxide sourced from local industrial emitters into the concrete during the manufacturing process, where it becomes chemically converted into solid calcium carbonate (limestone) embedded throughout the concrete block.
